

Sir/Madam,

The Ministry of Women and Child Development vide F.No.7-1/2016-CD-III dated 19th April, 2016 has allocated 4875 MTs of rice for 1st quarter and 4875 MTs for 2nd quarter of 2016-17 under What Based Nutrition Programme (WBNP) for Jammu and Kashmir State. The quota of 4875 MTs of rice for 1st quarter of 2016-17 which was to be lifted by 20th June 2016 got lapsed due to non allocation of food grains by the Administrative Department in time. 4875 MTs sanctioned for the 2nd quarter of 2016-17 under Wheat Based Nutrition Programme (WBNP) for Jammu and Kashmir State has been allocated to Jammu and Kashmir Province as per following breakup:-


