3. DPOs/DDOs will ensure that Expenditure Statement/UC should reach the office of the undersigned upto 5th of ensuing month failing which action under rule shall be initiated against the defaulting

4. The funds so released include the SC/ST Share (Component) and the Expdt shall be made wherever required as per the ratio.

5. The releases have been made strictly as per the number of functional AWCs.
