In order to ensure the proper monitoring of functioning of Anganwadi Centres along with special focus on quality and distribution of nutrition supply in the AWCs of J&K, the inter district teams (as per Annexure-A & B) to this order are hereby constituted with the mandate to carry random checking in the districts allotted to each team. They shall also interact with the local community for getting inputs about functioning of Anganwadi Centers. The teams shall submit their reports within a period of one week after conducting of checking duly signed by the members and the concerned PRIs of the area where the checking has been conducted. It is further ordered that Deputy Director of the concerned division shall co-ordinate the dates of the visits and other arrangements in consultation with chairperson of the team.
