**Eligibility Criteria:**

1. The NGOs/Voluntary Organizations registered under the Societies Registration Act, 1860.
2. NGOs/ Voluntary Organizations having Audited accounts for last 3 years and experience of minimum 3years for providing child care services to children between six months to six years.

**Terms and Conditions for Opening a Crèche:**

1. The Crèche units must be opened near the areas where large number of women are employed and work for 6-8 hours a day. The sights for opening crèches could be near Hospitals, Educational Institutions, Colleges, Universities, Government offices, Shopping malls, Industrial Areas, construction sites etc.
2. The crèche should be located near the homes of Children or near the place of work of the mother preferably at a walking distance i.e 1/2 to 1 Km.
3. The Crèche must be opened at least 02Kms away from the functional Anganwadi Center of particular area.

4. Ideally the Crèche should be opened where at least 25 beneficiaries in the age group 6 months- 6 years are present.
