- Women candidates in the age group of 18-37 years shall be considered for the post.
- The candidate should be a domicile of the UT of J&K.
- The candidate should be a resident of the Electoral Ward where AWC is located.
- Minimum Education qualification should be 10+2 pass and maximum graduation.
- Weightage shall be given on the basis of marks obtained in 10+2 and selection shall be granted purely on academic merit basis & there shall not be any interview.
- In case eligible candidate is available within the family of retired AWW the said candidate shall qualify for additional two percent points.
- Candidates with qualification higher than graduation shall not be considered.
- In case of tie in merit of the eligible candidate, candidate with higher age will be preferred.
