

Sanction is hereby accorded to release/revalidation of funds for the financial year 2015-16 to the tune of **Rs.181.76 lacs (Rupees One Crore, Eighty One lac and seventy six thousands) only** and placement of the same at the disposal of **District Programme Officers of Kashmir Province and District Programme Officer Doda for its further placement to concerned Child Development Project Officers as per annexure A"to this order** to meet the expenditure under the object head "**Upgradation of Anganwadi Centres**" during the current financial year 2015-16 (liability of 2014-15) subject to the following conditions:-

1. That the funds are utilized exclusively for the purpose for which these were originally released.
2. That all the codal formalities are observed before incurring the expenditure.
3. That no diversion or re-appropriation of funds is allowed in any case without the prior approval of the competent authority.
4. That the DDOs shall complete all the codal formalities before presentation of bills at the Treasury.
5. The utilization certificate of these funds should reach this office within fortnight; and The expenditure shall be debited to Account Head mentioned below:-
