

## Publication of Final Merit list of AWWs(Sangnis) 5<sup>th</sup> phase

It is to submit that 3 vacancies of sangnis have been identified in different AWCs of ICDS Project Batwara These vacancies were advertised vide notification no;72 of 2025 dated: 30.12.2025 in prominent local dailies viz Srinagar Times and Iqbal e Kashmir to receive applications from the eligible candidates of respective wards within the given time of 15 days. In response to said advertisement notice 18 applications were received by this office against 03 vacancies .The tentative merit list was framed by this office and after approval by the District Level Selection committee the tentative merit list was published in 3 local dailies i.e. Kashmir Observe, Srinagar News and Street Times, besides uploaded on District and Departmental website. to invite objections, no objection has been received by this office within stipulated time. Accordingly final merit list has been framed by this office in light of the marks obtained by the candidates in 12<sup>th</sup> class examinations and got approved by the District Level Selection Committee.
