- ❖ Women candidates in the age group of 18-37 years as on 01-01-2025 shall be considered for the post.
- ❖ The candidate should be a domicile of the UT of J&K.
- ❖ The candidate should be a resident of the Electoral Ward where AWC is situated. Name in the voter list for the ward shall be considered as per the proof of residence of the candidate. In case the name of the candidate appears in the voter list along with the parents, then she must provide certificate of being unmarried issued by concerned Tehsildar. However, if there is any dispute with regard to the residence for any reason then a residence proof certifying the ward of the residence from the concerned SDM/ACR shall be considered.
