Subject: - Publication of final seniority list of Matric and Graduate Anganwadi Workers District Kupwara.

NOTICE

WHEREAS, the Government of Jammu & Kashmir framed the J&K Social Welfare (Non-Gazette) Service Recruitment Rules, 1991 (SRO 287 dated 26.09.1991), SRO 16 dated 28th of January 2004 and SRO 335 dated 22nd of October 2009 and amended time to time

WHEREAS, revised instructions/guidelines were issued vide letter No. SW/ICDS/19/2010 dated 15-10-2010, which, among other things, stipulated as under:

"The experience of 5 years of higher qualification shall be considered from the date of acquiring it as a private candidate by the Anganwadi Worker for purposes of regularization as Supervisor."

WHEREAS, vide Government Order No. 100-SW of 2011 dated 20-05-2011, the instructions/guidelines pertaining to experience issued vide letter No. SW/ICDS/19/2010 dated 15-10-2010 have been rescinded ab-initio, and the experience of 10/5 years for graduate/matriculate Anganwadi Workers for selection as Supervisor shall be counted from the date of initial engagement as Anganwadi Worker and not from the date of acquiring such qualification whatsoever,

WHEREAS, in partial modification of the Government Order No. 100-SW of 2011 dated 20-05-2011, for selection of Anganwadi Workers as Supervisors, Government vide Order No. 22-SW of 2014 dated 24-01-2014 issued following guidelines:

i. The seniority of the Anganwadi Workers, who have acquired higher qualifications as private candidates during service, shall be taken from the date of acquiring the higher qualification instead of from the date of initial appointment.

ii. The honorarium drawn in respect of such Anganwadi Workers who have acquired higher qualifications without proper permission from the Competent Authority, shall be recovered from them for such period.

WHEREAS, the Government Order No. 100-SW of 2011 dated 20.05.2011 and Government Order No. 22-SW of 2014 dated 24.01.2014, issued under endorsement No. SW/ICDS/19/2010, were rescinded forthwith, vide Government Order No. 35-SW of 2017 dated 01-02-2017, issued under endorsement No. SW/ICDS/19/2010 dated 01-02-2017.

WHEREAS, the Government of Jammu and Kashmir, Social Welfare Department, issued Order No. 76-SW of 2019 dated 28-02-2019, which is reproduced as under:

"In light of the order passed by the Hon'ble High Court and in suppression of all previous orders issued on the subject, it is hereby ordered that: -

- i. The seniority of the Anganwadi Workers, who have acquired higher qualification (Graduation) during service shall be taken from the date of acquiring the higher qualification instead of their initial appointment.
- ii. For appearing in any examination for attaining higher qualification, Anganwadi Workers shall seek prior permission from the Mission Director, POSHAN J&K, through proper channel.
- iii. Honorarium drawn in respect of such Anganwadi Workers, who have acquired higher qualification without proper permission from the Competent Authority, shall be recovered from them for such period.
- iv. The Anganwadi Workers, who acquire higher qualification after seeking proper permission from competent authority, shall be asked to opt either of the two seniority lists maintained separately for matriculate and graduate Anganwadi Workers. Option once exercised shall be final



WHEREAS, various SWPs filed before the Hon'ble High Court of Jammu & Kashmir and Ladakh at Srinagar vide SWP 667/2018,SWP 369/2018,SWP 477/2019 SWP 750/2019,SWP 878/2019 regarding the selection of Anganwadi workers as Supervisors which is reproduced as under:-

"The seniority of the Anganwadi Workers, who have acquired higher qualification (Graduation) during service shall be taken from the date of acquiring the higher qualification instead of the date of their initial appointment."

WHEREAS, the Hon'ble High Court of Jammu & Kashmir and Ladakh at Srinagar clubbed these petitions together, as the focal point of these petitions was Clause-1 of Government Order 76-SW of 2019, dated 28-02-2019, regarding the selection of Anganwadi Workers as Supervisors and decided the SWP 667/2018,SWP 369/2018,SWP 477/2019 SWP 750/2019,SWP 878/2019 regarding the selection of Anganwadi workers as Supervisors on 14-02-2023, the operative part is reproduced as:-

"Viewed what has been observed, considered and analyzed hereinabove, the impugned Clause-1 incorporated in Government order no. 76-SW of 2019 dated 28.2.2019 issued by respondent 1 is quashed, as a consequence whereof the respondents are commanded to fix the seniority of Anganwadi Workers on the basis of their initial engagement as Anganwari Workers in tune with Rules of 1991 read with Rule 24 of the J&K CCA Rules".

WHEREAS, pursuant to the Mission Director communication letter No. MDP/Estt/Senty/Sang/2025/9775-9897 dated: - 26.03.2025 regarding updating of seniority list of Sanginis (Graduate/Matriculate) and in compliance with the Judgement dated 14.02.2023 passed by the Hon'ble High Court in SWP NO.667/2018, titled Syeda Nazir V/S State & Ors and other clubbed petitions, the tentative seniority list of Graduate AWWs is framed on the basis of their initial engagement.

WHEREAS, detail notification for publication of tentative seniority lists of Matric and Graduate Anganwadi Workers of District Kupwara have been issued vide this office notice under endorsement No.DPO/POSHAN/Kup/Estt/25/130-36 dated 16-04-2025 & No:-DPO/POSHAN/Kup/Estt/25/1821-26 dated 15-05-2025 which is published in newspapers Kashmir Horizon, JK Newspoint, Nigahbaan, The Kashmir Monitor & Kehwat

WHEREAS the tentative seniority lists of Matric and Graduate Anganwadi workers in District Kupwara have also been placed in public domain through the department's website at www.jkicds.com & https://kupwara.nic.in Hard copies were also made available in the offices of District Programme Officer ICDS Kupwara and Child Development Project officers of District Kupwara. These lists have also been circulated among zones and supervisors for dissemination of information at the Anganwadi level for submission of objections (if any).

WHEREAS, the objection(s) received by this office have been examined meticulously in the light of relevant rules /procedures and disposed off accordingly.

WHEREAS, the detail notification for submission of pending document pinpointed against each has been issued by this office under endorsement No. DPO/Poshan/Kup/Estt/25/674-85 dated 31-05-2025 and circulated among Child Development Project officers of District Kupwara and supervisors for dissemination of information at the Anganwadi level for submission of pending document as pin pointed against each.

WHEREAS, in response to above some Anganwadi Workers submitted the pending documents in this office which are taken on record.

WHEREAS, some Anganwadi workers were engaged in other districts and transferred to District Kupwara without any policy framework, and their seniority shall be reckoned from the parent district where they were engaged as Anganwadi workers. (Analogy of lien).

WHEREAS, given the ward/habitation-level selection process for Anganwadi workers, wherein only the highest-meritorious candidate within a specific ward or habitation is selected, and competitors are rendered non-meritorious or non-selected due to the selection process, and there is no relevant rule, to consider the seniority by comparing candidates across different wards/habitations or merit lists, since candidates selected in different wards/habitations are not competitors with each other at the time of selection. Merit or performance scores are typically used when multiple persons are selected from a single merit list, such as in cases of JKSSB, JKPSC, or district-level selections and merit cannot be used as tie breaker in case of Anganwadi workers selected in different merit lists in different electoral wards/habitations.

WHEREAS, when two or more Anganwadi workers are appointed on the same date, their seniority has been determined on the basis of their age.

WHEREAS, in cases where the date of initial engagement and date of birth are identical, the alphabetical order of names shall serve as the tie-breaker for determining seniority.

WHEREAS, the date of birth/Service bio-data/qualification as mentioned in the seniority lists have been authenticated by concerned DDOs (Child Development Project Officers) and they have also pin pointed the issue in the remark's column against each wherever required.

WHEREAS, those who have acquired higher education through regular or off-campus mode, as mentioned against each, are subject to clarification/acceptability of their degree courses or higher education by the competent authority. Merely being reflected in these seniority lists does not confirm their claim of having acquired higher education through regular or off-campus mode without the requisite approval or acceptance. And those who acquired higher education through regular mode and did not draw their honorarium or deposited back their honorarium, and were re-engaged by the competent authorities, with their seniority reckoned from the date of re-engagement, are also subject to acceptance by the competent authority.

WHEREAS, the degrees, diplomas, or certificates of acquired higher education are subject to verification of the mode, course, and recognition of the institution from which the degree or higher education was acquired. Merely being reflected in these seniority lists does not confirm their claims of higher education.

WHEREAS, those who have acquired higher education through Adeeb, Kamil, Fazil, Fazil-e-Urdu, or any other course that requires an equivalence certificate from the competent authority, are also subject to submission of an equivalence order/certificate from the competent authorities. Merely reflecting these degrees/higher education certificates does not confirm their claim as higher education.

WHEREAS, those who acquired graduation through distance mode without matriculation or 10+2 are subject to verification/acceptance by the competent authority. Merely reflecting their names in seniority lists does not confirm their claim of higher education.

WHEREAS, the final seniority lists of Matriculate and Graduate Anganwadi workers of District Kupwara have been framed by the office of District Programme Office ICDS Kupwara on the basis of their date of initial engagement or re-engagement (if any) which is attached at Annexure-A & B to this notice and also read the foot note at last page of annexed list with notification.

WHEREAS, the final seniority lists of Matriculate and Graduate Anganwadi workers in District Kupwara can be accessed online through the department's website at www.jkicds.com & https://kupwara.nic.in Hard copies are also available in the offices of District Programme Officer ICDS Kupwara and Child Development Project officer of District Kupwara. These lists have also been circulated among zones and supervisors for dissemination of information at the Anganwadi level.

Therefore, keeping in view the above-mentioned points, the final seniority lists of matriculate and graduate Anganwadi workers (appended at Annexure-A and Annexure-B) are hereby notified today, dated 08-09-2025. The seniority lists of matriculate and graduate Anganwadi workers shall be without prejudice to the outcome of writ petition(s), if any, pending for consideration before the competent court(s) of law.
