- ❖ Women candidates in the age group of **18-37 years** shall be eligible (age shall be calculated on the 1st day of calendar year i.e **01-01-2026**).

 Dated 28.04.2023 i.e,**

- ❖ Women candidates in the age group of 18-37 years shall be eligible (age shall be calculated on the 1st day of calendar year i.e 01-01-2026).
- ❖ The candidate should be a domicile of the UT of J&K.
- ❖ The candidate should be a resident of the Electoral Ward where AWC is located. Name in the voter list for the ward shall be considered as the proof of residence of the candidate. Wherever there is any dispute as to residence for any reason then residence proof certifying the ward of residence from the concerned SDM shall be considered.
- ❖ Minimum Education qualification should be 10+2 and maximum graduation.
- ❖ Weightage shall be given on the basis of marks obtained in 10+2 and selection shall be granted purely on academic merit basis & there shall not be any interview.
- ❖ In case eligible candidate is available within the family of retired AWW the said candidate shall qualify for additional two percent points.
